### **Purpose**

1. This paper provides you with the letters needed to complete the appointments to two university councils. It also provides you with letters to notify the Chancellors about your decisions and a letter of thanks to the outgoing Ministerial appointee.

## **Background**

- 2. The Cabinet meeting of 11 March 2019 will note your intention to make the following appointments:
  - Appoint Ms Rachael NEWSOME as a member of the University of Auckland council for a term from 1 April 2019 to 31 December 2022.
  - Reappoint Mr Ben VANDERKOLK as a member of the Massey University council from 1 April 2019 to 31 December 2021.
