## Important Updates and Changes

### Transitioning provider-based learners from TTAF to Fees Free for 2023

The Targeted Training and Apprenticeship Fund will end 31 December 2022. Where a learner's provider-based course starts in 2022 and ends in 2023, the TEC will apportion fees based on the portion of the course that occurs before 31 December 2022, based on the total number of days in the course. However, TTAF will cover full fees where:

- The course ends on or before 31 January 2023; or
- The amount payable by the learner is calculated to be \$10 or less.

TEOs should continue to report learner enrolments and fees to us as normal, and the TEC will calculate the funding for you. Where TTAF will not cover the full amount, the remaining is payable by the learner.

Learners who meet the 2023 eligibility criteria for Fees Free may be able to receive Fees Free for their study and/or training from 1 January 2023. It will not be possible to confirm the eligibility of learners until we have received the funding delegation for 2023. We will provide further information as soon as it is available.

### Remember to check the TTAF eligibility of your qualifications

With the Targeted Training and Apprenticeships Fund coming to and end on 31 December 2022, it's important to check that you have received approval for all qualifications that you believe meet the TTAF eligibility criteria. To receive funding, you must have [submitted a request](#) to the TEC, even if the

qualification is already listed on the [TTAF list of Qualifications and Programmes](#).

If you're unsure whether your organisation has received approval for a qualification, contact your Relationship Advisor or the Customer Contact Group for assistance.

## Tips for Reporting Study

The increased limit in the Fees Free validation that allows you to report higher fees under the [Annual Maximum Fee Movement](#) has now been removed, and we have noticed an increase in fees failing validation. Please ensure the fees that you report in your All Enrolments and Costs returns are less than or equal to the fees in STEO for each course.

We will not allocate for any fees that exceed the fees approved in STEO. You can check your Multiple Providers and Cap Limit report to find out how much we are allocating to you per learner based on your most recent return. Your Data Validation report provides more detail on any errors we have identified in your return.
